NOTES FOR GROUP MEMBERS

All logs must be submitted by the required date and must include in them the following facts

1. Route plan/map.
2. Campsite diagram/sketch for every campsite to include:
  - a. North point
  - b. Wind direction
  - c. Position of tents and campsite facilities
  - d. Any other relevant information
3. Group members (and roles).
4. Equipment taken by group.
5. Individual kit.
6. Menus planed/used
7. Hourly log to include notes on:
  - a. weather
  - b. moral
  - c. map referance
  - d. general points of interest
8. Written objective.

Notes to Assesors.

Will each group leader arrange a meeting with the other assesors in his group to check each log, the group leader will decide if the log contains all the facts required (see notes for group members above) if so and of a reasonable presentation award an immediate pass; if the log does not contain all the facts required it should be returned to the boy/girl and their company comander notified of this. If the log contains all the facts required but is of doubtful quality it should be noted for discussion at the full assesors meeting which you should attend bringing the logs with you.

The logs meeting will be on Saturday 19th May 1979, at 77 Rochester Road, Gravesend, Kent. commencing at 7.30 p.m.

There will also be a meeting of assesors at the above address on Sunday 22nd April 1979, for any assesors who wish to discuss any points about the Wales expedition. This meeting will commence at 8.00 p.m.
