

ROAD TRAFFIC ACT 1960

- (c) All the passengers must be carried to, or to the vicinity of the destination specified, or, in the case of a tour, be carried for the greater part of the journey.
- (d) Each passenger must pay the same fare irrespective of distance travelled.
- (e) In the case of a journey to a particular destination, the passengers must not include any person who frequently or as a matter of routine, travels at, or about the same time of day, at which the journey shall be made to the destination, from a place from or through which the journey is being made.




